PY 19-20 ELIGIBILITY APPLICATIONS RENEWAL EFFECTIVE JULY 1, 2019

Eligibility Applications were mailed on July 1, 2019 to Providers who:

- Live in a Tier 1 area and previously (in PY 18-19) qualified to claim own, foster or other residential children.
- Live in a Tier 2 area and previously (in PY 18-19) qualified for Tier 1 reimbursement and qualified to claim own, foster or other residential children.
- Live in a Tier 2 area and previously (in PY 18-19) the Parent/Guardian of the children in their care complete Eligibility Applications and qualified.

Please read all Eligibility Application Renewal Instructions carefully. All Eligibility Applications must be completed and dated in July 2019. Completed Eligibility Applications must be in our office on or before July 19, 2019.

Applications with errors, write-overs, scratch-outs, etc. will be returned to the Provider or Parent/Guardian for corrections. Applications received after July 19, 2019 could mean a loss of reimbursement money. **Don't delay in completing your Eligibility Applications and mailing them to our office before July 19, 2019.**

SUMMER IS A BUSY TIME FOR EVERYONE. ENJOY YOUR SUMMER . . . AND REMEMBER TO:

- Keep your menus and meal counts (attendance) up to date.
- Call the office in advance when you are not going to be home during a scheduled meal time, closed, or not claiming.
- Document school-out days for children on summer break.

NEW FEDERAL ELIGIBILITY GUIDELINES FOR PY 19-20 (July 1, 2019 to June, 30 2020)

If you have not previously qualified to claim own children **OR** live in a Tier 2 area and feel your income is now within the guidelines below, **OR** if your household now receives Cal Fresh, Cal Works, FDPR; please call the office and request an Eligibility Application before July 19, 2019.

June 2019 reimbursement checks will be mailed in August 2019

July 2019 reimbursement checks will be mailed in September 2019

*Checks are mailed within 5 Business days of receiving the funds from CDE

Checks for late claims are mailed when within 5 Business days of receiving the late run funds from CDE
