2024-2025 ELIGIBILITY APPLICATIONS

Eligibility Applications for Providers claiming own children, foster children or any other residential children is due in our office on July 26, 2024. Providers who live in a Tier 2 area qualifying for Tier 1 reimbursement Eligibility Application is also due in our office on July 26, 2024. If you have not mailed your Eligibility Application to claim own children, foster children or residential children or live in a Tier 2 area qualifying for Tier 1 please do so immediately.

UPDATING ENROLLMENTS FOR CHILDREN STARTING KINDERGARTEN OR TK (TRANSITIONAL KINDERGARTEN) AND CHILDREN STARTING FIRST GRADE. MAKE SURE THAT ALL OF YOUR SCHOOL AGE CHILDREN'S HOURS ARE UP TO DATE.

If you have any children that have started Kindergarten or T-K (Transitional Kindergarten) in August you will need to update their Enrollment Report information in August.

If you have any children that were ½ day kindergarten last year and will start 1st grade in August, you will need to update their Enrollment Report information.

KidKare Providers should print the existing Child Enrollment Report, make changes with an ink pen, have the parent sign and date and mail one copy to our office.

PY 24-25 INCOME ELIGIBILITY APPLICATIONS RENEWAL FOR JULY 1, 2024

Eligibility Applications were mailed on June 30, 2024 to Providers who:

- *Live in a Tier 1 area and previously (in PY23-24) qualified to claim own, foster, or other residential children.
- *Live in a Tier 2 area and previously (in PY23-24) qualified for Tier 1 reimbursement to claim own, foster, other children, and the children in their care.
- *Live in a Tier 2 area and previously (in PY23-24) and had the parents of the children in their care complete Eligibility Applications.

Please read all instructions carefully. Completed Applications are due in our office on or before July 26, 2024. <u>All applications</u> <u>must be dated with the date you completed the application in July 2024.</u>

Applications with errors, write-overs, scratch outs, etc. will be returned to the provider or parent for corrections. Applications received after July 26, 2024 could mean a loss of reimbursement money for the Provider. **Don't delay in completing your Eligibility Applications and mailing them to our office before July 26, 2024.**
